Religious Education and World Views Policy

We know that God loves us; we show it by being loving, honest and respectful.

Introduction

Religious Education (RE) is unique in the school curriculum in that it is neither a core or foundation subject, however the 1988 Education Act states that 'Religious Education has equal standing in relation to core subjects of the National Curriculum in that it is compulsory for all registered pupils'.

Religious Education and World Views is taught in our school because it makes:
"A major contribution to the education of children and young people. At its best, it is intellectually challenging and personally enriching. It helps young people develop beliefs and values, and promotes the virtues of respect and empathy, which are important in our diverse society. It fosters civilised debate and reasoned argument, and helps pupils to understand the place of religion and belief in the modern world". (RE: Realising the Potential, Ofsted 2013).

According to the 2011 Statement of Entitlement to RE in C of E schools, the aims of Religious Education in church schools are:

- To enable pupils to encounter Christianity as the religion that shaped British culture and heritage and influences the lives of millions of people today
- To enable pupils to learn about the other major religions, their impact on culture and politics, art and history, and on the lives of their adherents
- To develop understanding of religious faith as the search for and expression of truth
- To contribute to the development of pupils' own spiritual / philosophical convictions, exploring and enriching their own faith and beliefs
- To teach children the British values of democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs. (2014)

Teaching and Learning about Christianity

Christianity is the major religion which is studied in our school. In line with the Wiltshire Agreed Syllabus, between two thirds and half of our RE teaching will be about Christianity. Understanding Christianity is the main resource that we draw on in planning and delivering our teaching of Christianity as a living world religion. This ensures that we draw on the richness and diversity of Christian experience in all its worldwide forms. Pupil's learning experience should be an open one which stems from and instils respect for different views and interpretations, and in which real dialogue and education takes place. Pupils will be enabled to deepen their understanding of God as encountered by Christians.

Teaching and learning about other faiths and world views

We have a duty to foster an accurate and increasing understanding of world religions and world views. As a result, pupils will gain greater insight into the world in which they are growing up. They will be able to appreciate the faith and beliefs of others, whilst developing a deeper understanding of their own beliefs and practices. This learning should contribute to harmonious relationships, whilst promoting social inclusion without prejudice.

We also use materials in 'The Emmanuel Project' to resource and teach these lessons. This ensures that we revisit and build on the children's prior learning about other world views and religions. It encourages a growing and relevant understanding of other faiths and world views.

Organisation

- We deliver RE and WV in line with the locally agreed Wiltshire syllabus.
- We plan units of work using 'The Emmanuel Project' as a scheme to deliver content about Christianity, other world faiths and views.
- We have adopted a curriculum map from 'The Emmanuel Project' for RE and WV in order to ensure appropriately balanced coverage and curriculum teaching time in line with the Wiltshire locally agreed syllabus.
- We believe that RE and WV is about subject knowledge, critical / evaluative thinking as well as personal spiritual development.
- RE and WV is an important part of the whole education of the child and threads throughout the curriculum.
- RE and WV will be allocated at least 5%, and up to 10% of curriculum time.
- RE and WV will be taught to all pupils unless any parent exercises their right for their child to be withdrawn (see below in 'Legal Status').
- RE and WV is sometimes taught in the form of whole school RE Days which cover a unit of work for each class in a creative and engaging way, allowing for a deeper understanding to be explored.

Approach

The RE and WV that is taught in classes should reflect the needs of the pupils, and careful planning should ensure progression in understanding for all. Lessons will be well planned, adopting a range of teaching strategies including class, group and individual learning activities. The use of art, drama, music, story, artefacts, discussion and questioning, reflection, visits and visitors are all vehicles for effective teaching and learning in the subject.

Special Needs

To ensure inclusion for all pupils, teachers will respond to pupils' diverse learning needs and set suitable and appropriate tasks. Provision for children with special needs will be met from the resources and expertise available within our school in accordance with the Special Needs Policy.

Legal Status

The Governors of St Andrew's CE VA Primary School are responsible for the Religious Education and World Views Policy of the school. The policy has been drawn up by the RE and WV Lead, with the approval of the staff and Head Teacher. The Religious Education and World Views Policy for the school follows the guidelines set out in the agreed syllabus for Wiltshire and those of the Diocesan Board of Education.

Recording and Assessment

Assessment is part of the teaching and learning process and as such is planned into lessons as needed. During the academic year, summative assessment takes place at the end of the units of work based on Creation, Incarnation and Salvation for Christianity and at the end of the year for the work based on other World Views. This is recorded to aid planning for future lessons. Assessment may take place in a variety of different ways, including oral question-and-answer sessions based on discussion and reflections on completed work. Assessment for each child in every class is recorded in the school's tracking documents within Insight. This allows teachers to adjust their planning to meet the learning needs of their pupils and ensure their learning is appropriately matched. Further evidence of children's work can be found in their individual RE books from Year 2 onwards, and in Class floorbooks. There is an expectation that there are 6 pieces of work per term across both of these books which relevant to the children's responses.

Role of the Subject Leader

The RE and WV leader is responsible for:

- The monitoring and review of this policy with the staff and Ethos Committee.
- Assembling and organising relevant resources.
- Attending relevant training and providing feedback to staff and governors as appropriate.
- Providing CPD from training to meet the needs identified by teachers
- Lead Governors and staff in evaluating RE and WV, and Collective Worship
- Assisting staff with the planning and delivery of RE and WV in line with the provision outlined in the curriculum map.
- Completing book scrutinies, pupil conferencing and lesson observations across all year groups.
- Analysing and reporting on standards of RE and WV across the school, identifying strengths to celebrate and areas for improvement.

Monitoring and Review

The teaching and learning of RE and WV will be monitored and reviewed annually by the RE and WV leader and governors. The RE and WV lead will observe lessons, complete book scrutinies and conference pupils. The Governors who form the Ethos Committee will also complete book scrutinies and pupil conferencing.

The RE and WV Policy is reviewed by the Head Teacher, RE and WV Lead, and Teaching Staff and Governors annually.
